Executive Job Matching: Estimates from a Dynamic Model (Job Market Paper)

Abstract: I evaluate how learning about CEO-firm match quality affects CEO turnover decisions and the cross-sectional distribution of CEO pay. In the model, belief-contingent turnover eliminates lowquality matches and skews CEO compensation distribution to the right. Bringing the model to the CEO compensation data, I find that learning explains the widespread skewness of CEO pay controlling for firm and CEO characteristics. Consistent with the learning mechanism, I also observe a hump-shape hazard rate curve of CEO turnover conditional on CEO tenure and an increasing and concave correlation between CEO compensation and the likelihood of CEO tenure continuation in a hand-collected dataset of CEO turnover. In short, learning and selection of the match quality justify the relation of CEO compensation, turnover and firm performance.
